### Our Program

### Eligibility Criteria

Organizations should meet the following criteria in order to be eligible for an LTCP grant. They must:

- ▶ hold a current tax-exempt status under Section 501(c)(3) of the Internal Revenue Code
- ▶ provide services within LTC Partners' three focus areas
- ▶ operate in the NH Seacoast area (NH, ME, MA)

LTC Partners does not fund individuals, religious organizations, and political causes, including candidates for public office, political organizations, or legislative, lobbying, or advocacy efforts. We do not fund organizations that discriminate by race, color, creed, sexual orientation, national origin, or disability. We also cannot fund organizations, programs, and projects that pose a potential conflict of interest for our business.

### Applying for a Grant

You may apply for a grant by completing the application on the following page. LTC Partners will provide an initial acknowledgement of receipt of your request via email. **Requests are reviewed on a quarterly basis.** LTC Partners will send a formal response to your application indicating if the request was granted or denied. If granted, LTC Partners will include in our response an estimated timeframe for the distribution of funds.
